The Algerian Electricity and Gas Company – Renewable Energies “Sonelgaz - EnR” launches a National and International Open Call for Tenders No. 112/S-Eng/2024 with the aim of:

Study, engineering, civil works, supply, transport, assembly, training, testing and commissioning of three (03) photovoltaic solar power plants including their connection works to the electricity transport network:

Lot 01: PV plant with a power of 120 MWp in Kenadsa (Wilaya of Béchar)

Lot 02: PV plant with a power of 150 MWp in Touggourt (Wilaya of Touggourt)

Lot 03: PV plant with a power of 250 MWp in Tamacine (Wilaya of Touggourt)

This Call for Tenders is aimed at companies operating in the energy sector with the capacity to carry out all the services covered by the call for tenders and proven and authenticated references in the EPC implementation of:

For foreign companies participating alone or in a group of foreign companies:

Photovoltaic solar power plant projects with a total power of 40 MWp and more.

For foreign companies participating in a group with Algerian companies:

Photovoltaic solar power plant projects totaling a power of 25 MWp and more for foreign companies, and Large-scale industrial and energy projects or projects on behalf of Sonelgaz Group companies for Algerian companies.

For participating Algerian companies alone or in groups of Algerian companies:

Large-scale industrial and energy projects or projects on behalf of Sonelgaz Group companies.

The Project Owner reserves the right to verify the information provided by each bidder at any time during the Invitation to Tender process.

Any Bidder, alone or in a group, can only rely on their own qualifications and professional references.

The Specifications must be withdrawn by the candidate or his duly designated representative. In the case of a group, the Specifications must be withdrawn by the agent or his duly designated representative, unless otherwise provided in the group agreement.

A member of a bidding group cannot be a sole bidder or be part of another group among the Bidders.

For this Call for Tenders, each Bidder may bid for one Lot, two Lots or all three Lots.
